Job title: Class teacher

Salary: Main Scale / Upper pay scale Contract type: Permanent full-time Reporting to: Phase Leader

## Main purpose

The teacher will do the following:

- > Fulfil the professional responsibilities of a teacher, as set out in the School Teachers' Pay and Conditions Document
- ➤ Meet the expectations set out in the Teachers' Standards

#### **Duties and responsibilities**

### Teaching

- Plan and teach well-structured lessons to assigned classes, following the school's plans, curriculum and schemes of work
- Assess, monitor, record and report on the learning needs, progress and achievements of assigned pupils, making accurate and productive use of assessment
- Adapt teaching to respond to the strengths and needs of pupils
- > Set high expectations which inspire, motivate and challenge pupils
- Promote good progress and outcomes by pupils
- Demonstrate good subject and curriculum knowledge
- Participate in arrangements for preparing pupils for external tests

## Whole-school organisation, strategy and development

- > Contribute to the development, implementation and evaluation of the school's policies, practices and procedures, so as to support the school's values, mission and vision
- Make a positive contribution to the wider life and ethos of the school
- > Work with others on curriculum and pupil development to secure co-ordinated outcomes
- > Provide cover, in the unforeseen circumstance that another teacher is unable to teach
- Contribute in further developing school's provision by completing actions within the School Improvement Plan
- > Effectively lead a subject/area of responsibility to ensure the best outcomes for pupils
- > Keep up to date with developments within their subject and disseminate to staff where appropriate.

## Health, safety and discipline

- Promote the safety and wellbeing of pupils
- Maintain good order and discipline among pupils, managing behaviour effectively to ensure a good and safe learning environment
- > Adhere to the school's Code of Conduct Policy for Staff
- > Follow the school's Code of Conduct and Exclusions Policy for children when dealing with inappropriate behaviour

#### **Professional development**

> Take part in the school's appraisal procedures

- > Take part in further training and development in order to improve own teaching
- > Where appropriate, take part in the appraisal and professional development of others
- > Respond appropriately to feedback on performance.

### Communication

- > Communicate effectively with pupils, parents and carers
- Communicate effectively with staff and visitors
- > Communicate any questions, concerns or information with the most relevant, appropriate member of staff. (e.g. Subject Leader, Phase Leader, SLT, DSL etc)

### Working with colleagues and other relevant professionals

- > Collaborate and work with colleagues and other relevant professionals within and beyond the school
- > Develop effective professional relationships and dialogue with colleagues

#### Personal and professional conduct

- Uphold public trust in the profession and maintain high standards of ethics and behaviour, within and outside school
- ➤ Have proper and professional regard for the ethos, policies and practices of the school, and maintain high standards of attendance and punctuality
- Understand and act within the statutory frameworks setting out their professional duties and responsibilities.

#### Management of staff and resources

- Direct and supervise support staff assigned to them, and where appropriate, other teachers
- Contribute to the professional development of other teachers and support staff
- Deploy resources delegated to them.

### Safeguarding and Child Protection

- > Safeguard and promote the welfare of children and young people
- Follow school's safeguarding policies and the latest legislation
- > Provide a safe environment in which children can learn
- > Be prepared to identify children who may benefit from early help.
- Report any concerns about a child's welfare following the referral processes set out in the school's Child Protection and Safeguarding Policy.

## **Upper Pay Scale Teachers**

- Maintaining consistently high standards in relation to all aspects of the Teachers' Standards
- > Demonstrating effective practice and helping others to evaluate the impact of their teaching on learners' achievement
- > Contributing significantly to implementing workplace policies
- Being a role model for learners and other staff
- Making a significant contribution to school development
- > Set an example, share good practice and support other colleagues in maintaining the standards
- ➤ Use data effectively, demonstrating analytical thinking in reviewing and evaluating progress and attainment, and in meeting appropriate, challenging targets for all pupils.
